- 2. Bids received in excess of the ABC shall automatically be rejected at Bid opening. Late bids shall not be accepted.
- DENR now invites Bids from authorized Suppliers/Distributors/Dealers for the Supply, Delivery, Installation and Testing of Various Brand New Air Conditioning Units for DENR (hereinafter referred to asGOODS).
- 4. Bidders may bid for one or all lots. Separate Bid Security for each lot being bid.
- 5. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its Revised IRR.
- 6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 7. A prospective Bidder must have completed within last five (5) years a Single contract of similar nature amounting to at least fifty percent (50%) of the total ABC of the lot/s being bid.
  - "Similar nature", for purposes hereof, shall mean "Air Conditioning System".
- 8. Completion must be within the prescribed period specified below from receipt of Notice to Proceed (NTP):
