



Invitation to Bid for Completion of the Rehabilitation of the Depository Area for the Confiscated Forest Products of DENR Caraga

1. The *DENR-R13, Regional Office*, through the *GAA Fund 101, CY 2024* intends to apply the sum of *Two Million One Hundred Twenty-Two Thousand Eight Hundred Sixty Pesos and Seventy-Two Centavos (Php2,122,860.72)* being the Approved Budget for the Contract (ABC) to payments under the contract for *the Completion of the Rehabilitation of the Depository Area for the Confiscated Forest Products of DENR Caraga/Project Reference No. 2024-03-01*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DENR-R13, Regional Office* now invites bids for the above Procurement Project. Particularly described hereunder:

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *DENR-R13, Regional Office* and inspect the Bidding Documents at the address given below from *Mondays-Fridays, 08:00 A.M.-05:00 P.M.*

5. A complete set of Bidding Documents may be acquired by interested bidders on *March 23, 2024* from the given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *either it will be presented in person, by facsimile, or through electronic means*.
6. The *DENR-R13, Regional Office* will hold a Pre-Bid Conference¹ on *April 1, 2024, at 02:00 P.M. (BAC biometric time)* through videoconferencing/webcasting *via Zoom*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before *April 15, 2024, 11:30 A.M. (BAC biometric time)*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on *April 15, 2024, 01:30 P.M. (BAC biometric time), Regional Learning Center, DENR Caraga, Regional Office, Brgy. Ambago, Butuan City*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. *Use back-up data or cloud storage for large files uploaded for online bid submissions.*
11. The *DENR Caraga, Regional Office* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
